4.2 Quality and importance

Il sito è caratterizzato da una prateria a Posidonia (habitat prioritario) di piccola estensione che confina con le formazioni a Cymodocea e con zone rocciose. Di notevole interesse è il fatto che l'habitat della prateria a Posidonia penetra nel Golfo di Levante fino a meno di un metro di profondità.
